Burrard Landing is the retail component of Vancouver's newest Convention Centre – Vancouver Convention Centre West. It comprises approximately 87,000 square feet of LEED Platinum certified retail, office and patio space. All premises provide stunning views of Coal Harbour, the Burrard Inlet and North Shore Mountains, as well as high traffic exposure and accessibility by foot, transit, car, and seaplane. Highlights include:



LOCATION OVERVIEW

Burrard Landing is at the core of the Downtown Vancouver's tourist district in the Vancouver Convention Centre West. The Jack Poole Plaza (home of the Olympic Cauldron), Bon Voyage Plaza next to Canada Place's cruise ship terminal, and Vancouver's world famous Seawall all draw significant people to this area.
