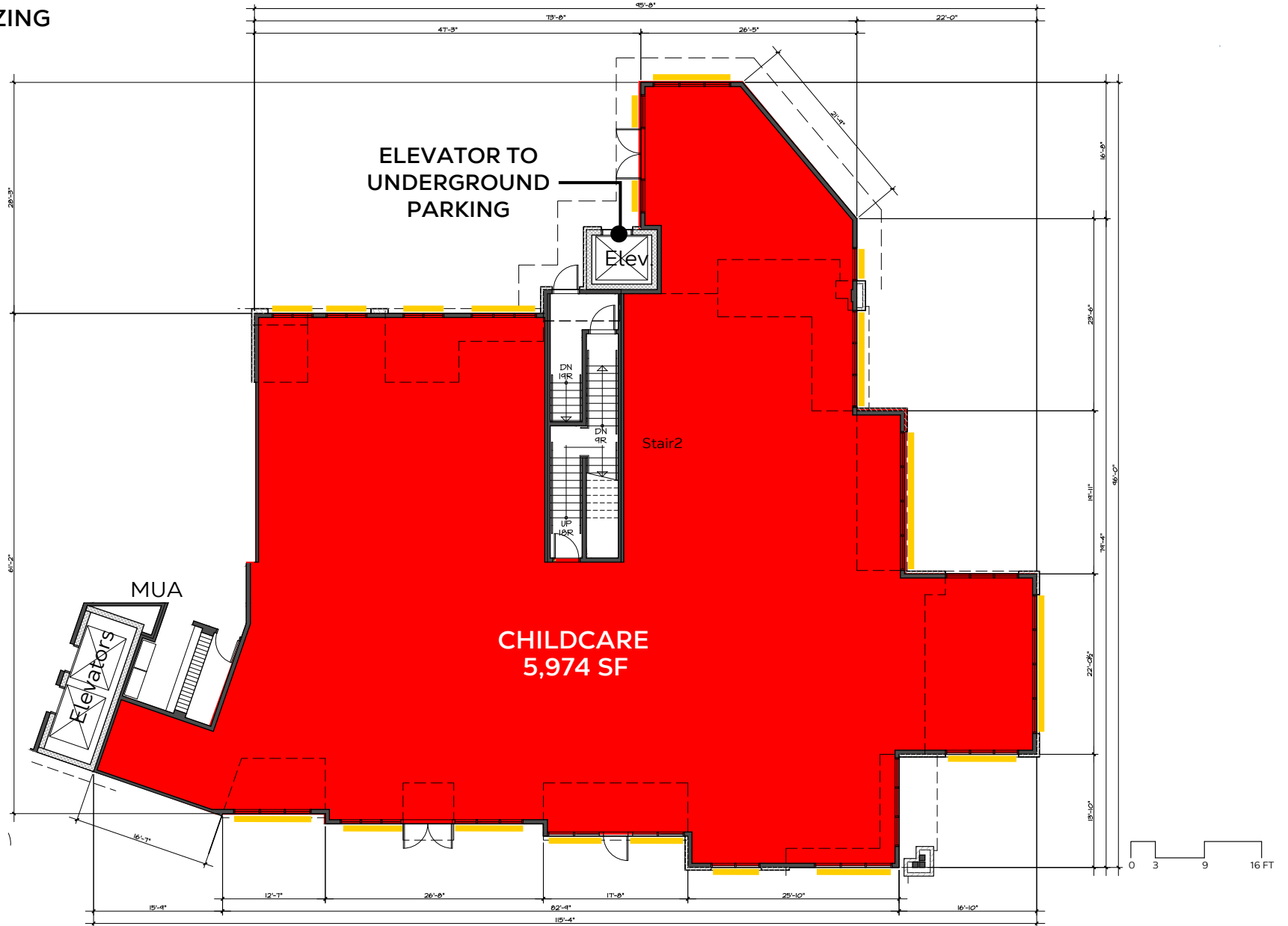

FLOOR PLAN

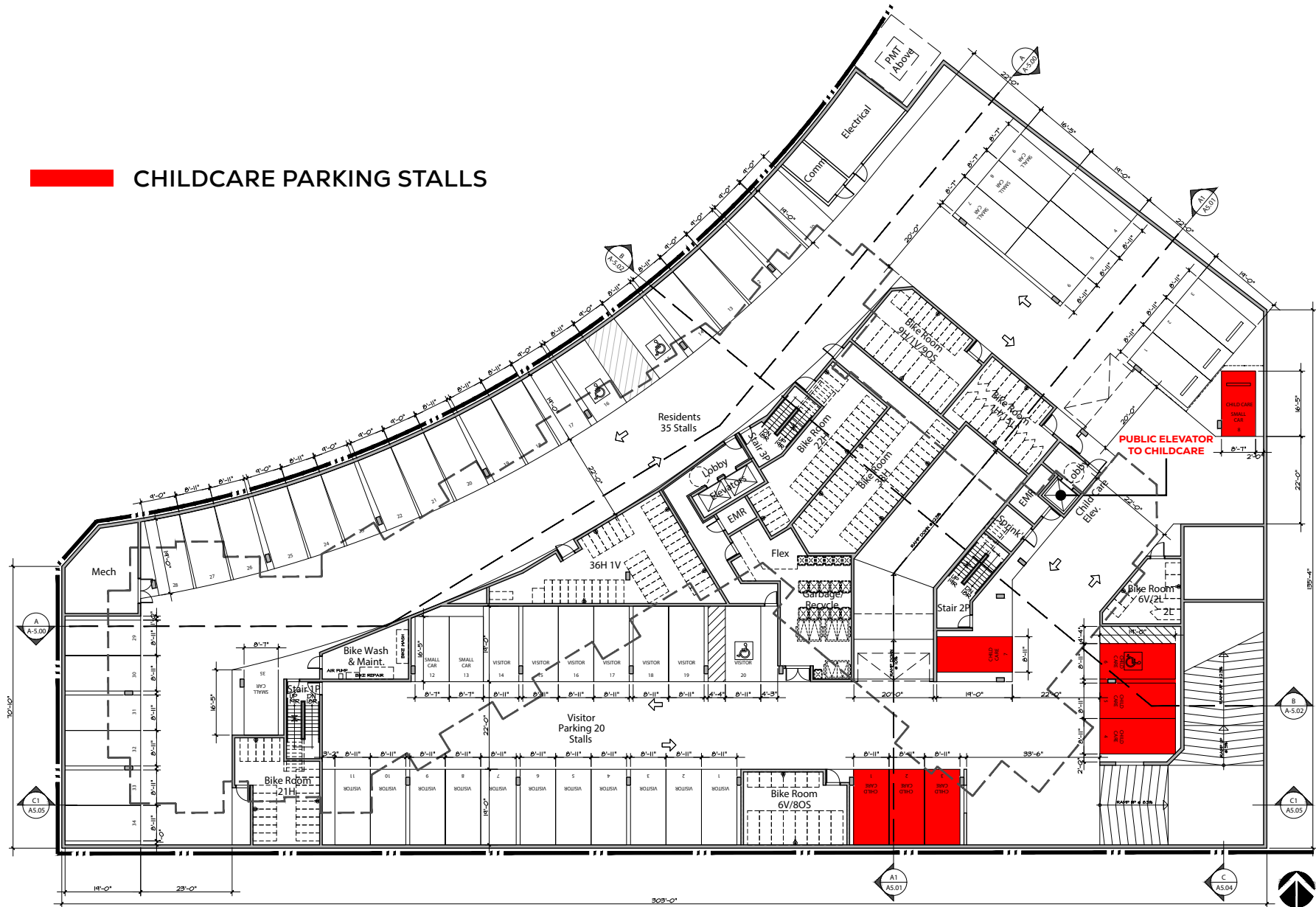
